### **Hotel Reservations**

We were able to secure a government room rate of \$135.00 a night. Conference attendees must make their hotel reservations with the Hyatt Regency Hotel at 1-800-233-1234. Please reference the CGIA National Gang Conference to obtain the conference rate of \$135 plus tax, single or double occupancy. Attendees may also make their reservations online at <https://aws.passkey.com/go/cagang2018>. The room rate is available until July 20<sup>th</sup>, 2018. Hotel rooms may be available after this cut-off date; however, the prevailing rate will be charged. The Hyatt requires a deposit by check, money order, or accepted credit card for the first night to reserve and guarantee accommodations.

To guarantee the discounted rate, reserve rooms early, prior to the July 20th deadline. Check-in time is 4:00 PM; check-out is 12:00 PM. The hotel does not have airport shuttle service.
